ORDER

MADE BY THE COMMISSIONER OF POLICE UNDER SECTION 68(1) OF THE
MOTOR VEHICLES AND ROAD TRAFFIC ACT

THE TRAFFIC RESTRICTION (TEMPORARY PROVISIONS)
(LABOUR DAY CELEBRATIONS—FYZABAD) ORDER, 2025

1. This Order may be cited as the Traffic Restriction (Temporary Citation
Provisions) (Labour Day Celebrations—Fyzabad) Order, 2025.

2. This Order has effect on Thursday 19th June, 2025, from Duration
6.00 a.m. to midnight.

3. (1) From 6.00 a.m. to midnight, the driver of a motor vehicle Parking
shall not park on the following roads: prohibited

- (a) Fyzabad-Guapo Road, between Uriah Butler Avenue and Gowers Well Road;
- (b) Easy Street, between Fyzabad-Guapo Road and Coolman Trace;
- (c) Coolman Trace, between Easy Street and Fyzabad-Guapo Road;
- (d) Fyzabad-Guapo Road, between Coolman Trace and Uriah Butler Avenue;
- (e) Lum Tack Hill;
- (f) Delhi Road, between Fyzabad-Oropouche Road and Mon Desir-Delhi Road;
- (g) Fyzabad-Oropouche Road, between Fyzabad Junction and Avocat Junction;
- (h) Gowers Well Road, between Fyzabad-Guapo Junction and Patterson Street;
- (i) John Jules Trace, between Delhi Road and Gowers Well Road;
- (j) Uriah Butler Avenue; and
- (k) Fyzabad-Oropouche Road, between Lum Tack Hill and Jimdar Street.

(2) From 6.00 a.m. to 2.00 p.m., the driver of a motor vehicle shall not park on the following roads:

- (a) Siparia Old Road, between Avocat Junction and Samlal Trace; and
- (b) Fyzabad-Oropouche Road, between Avocat Junction and Jebodhsingh Street.

Vehicular

4. From 6.00 a.m. to 10.00 p.m., the driver of a motor vehicle shall not proceed along the Fyzabad-Guapo Road, between Uriah Butler Avenue and Charlie King Junction.

Traffic routes

5. (1) The driver of a motor vehicle proceeding to Fyzabad from Oropouche along the Fyzabad-Oropouche Main Road, shall proceed in a south-easterly direction at Avocat Junction onto Siparia Old Road, and then west onto Fyzabad-Guapo Main Road.

(2) The driver of a motor vehicle proceeding to San Fernando or Point Fortin, *via* Fyzabad, shall proceed in a westerly direction along Delhi Road, then north-west onto Mon Desir-Delhi Road, and then onto Solomon Hochoy Highway Extension.

(3) From 9.00 a.m. to 10.00 p.m., the driver of a motor vehicle proceeding to Siparia *via* Fyzabad along Delhi Road, shall proceed south onto Khan Trace, then west onto Winston Campbell Street, then south-east onto Gowers Well Road, then south along the Fyzabad-Guapo Road and—

- (a) continue south along Fyzabad-Guapo Road towards Sudama Village and Spring Trace; or
- (b) proceed in an easterly direction onto Uriah Butler Avenue and continue in a south-easterly direction along Fyzabad-Guapo Road.

Two-way
traffic

6. The driver of a motor vehicle may proceed along the Fyzabad-Guapo Main Road in either a northerly or southerly direction, between Lum Tack Hill and Bhola's Hardware.

Removal of
vehicles

7. Without prejudice to any other liability incurred by the commission of a traffic violation, a member of the Police Service may, in accordance with section 108 of the Act, remove or cause to be removed a vehicle that is parked in contravention of this Order, or left on any road in such a manner that it is likely to cause an obstruction to persons lawfully using the road.
