ORDER

Made by the Commissioner of Police under Section 68(1) of the Motor Vehicles and Road Traffic Act

THE TRAFFIC RESTRICTION (TEMPORARY PROVISIONS) (SIPARIA BOROUGH J'OUVERT CELEBRATIONS) ORDER, 2025

1. This Order may be cited as the Traffic Restriction (Temporary Citation Provisions) (Siparia Borough J'ouvert Celebrations) Order, 2025.

2. This Order has effect on Saturday 21st June, 2025, from Duration 1.00 a.m. to 2.00 p.m.

- 3. A driver of a motor vehicle shall not park on the following roads: Parking prohibited
 - (a) Bermudez Trace, between San Fernando-Siparia-Erin Road and Allies Street;
 - (b) Allies Street, between San Fernando-Siparia-Erin Road and Victoria Street;
 - (c) Victoria Street, between Allies Street and La Pastora Street;
 - (d) La Pastora Street, between San Fernando-Siparia-Erin Road and Railway Road;
 - (e) Railway Road, between La Pastora Street and San Fernando-Siparia-Erin Road;
 - (f) San Fernando-Siparia-Erin Road, between Well Road and La Pastora Street;
 - (g) Siparia Old Road, between San Fernando-Siparia-Erin Road and Park Street;
 - (h) Park Street, between Siparia Old Road and Gambal Street;
 - (i) Gambal Street, between Park Street and Grell Street;
 - (j) Grell Street, between Gambal Street and San Fernando-Siparia-Erin Road;
 - (k) Villabrera Street to Well Road, between Siparia Old Road and San Fernando-Siparia-Erin Road;
 - (l) San Fernando-Siparia-Erin Road, between Siparia Old Road and Grell Street;

- (m) Daisy Voisin Street, between San Fernando-Siparia-Erin Road and Victoria Street;
- (n) Coora Road, between San Fernando-Siparia-Erin Road and Victoria Street;
- (o) Edward Street, between San Fernando-Siparia-Erin Road and Victoria Street;
- (p) George Street, between La Pastora Street and Allies Street;
- (q) Mary Street, between La Pastora Street and Allies Street; and
- (r) De Gannes Lane, between Siparia Old Road and De Boulette Street.
- 4. A driver of a motor vehicle shall proceed in a-
 - (a) westerly direction only, along Bermudez Trace, between San Fernando-Siparia-Erin Road and Allies Street;
 - (b) southerly direction only, along Allies Street, between Bermudez Trace and Victoria Street;
 - (c) westerly direction only, along Victoria Street, between Allies Street and La Pastora Street;
 - (d) southerly direction only, along La Pastora Street, between Victoria Street and Railway Road;
 - (e) westerly direction only, along Railway Road, between La Pastora Street and San Fernando-Siparia-Erin Road;
 - (f) easterly direction only, along San Fernando-Siparia-Erin Road, between Well Road and La Pastora Street;
 - (g) northerly direction only, along Siparia Old Road, between San Fernando-Siparia-Erin Road and Park Street;
 - (h) easterly direction only, along Park Street, between Siparia Old Road and Gambal Street;
 - (i) easterly direction only, along Gambal Street, between Park Street and Grell Street;
 - (j) southerly direction only, along Grell Street, between Gambal Street and San Fernando-Siparia-Erin Road; and
 - (k) westerly direction only, along Villabrera Street to Well Road, between Siparia Old Road and San Fernando-Siparia-Erin Road.

One-way traffic

- 5. A driver of a motor vehicle proceeding to— Traffic route
 - (a) Penal from Erin or Santa Flora along San Fernando-Siparia-Erin Road, shall turn north onto Siparia Old Road, then east onto Park Street, then south onto Grell Street, and then east onto San Fernando-Siparia-Erin Road to Penal;
 - (b) Fyzabad, Oropouche from Erin or Santa Flora along San Fernando-Siparia-Erin Road, shall turn north onto Siparia Old Road to Fyzabad; and
 - (c) Erin from Penal, shall proceed in a westerly direction along San Fernando-Siparia-Erin Road, then turn south onto Bermudez Trace, then south onto Allies Street, then west onto Victoria Street, then south onto Railway Road, and then turn west onto San Fernando-Siparia-Erin Road to Erin or Santa Flora.
- 6. Taxi stands shall operate as follows:

Relocation of taxi stands

- (a) the San Fernando Taxi Stand shall be relocated to the Daisy Voisin Hub;
- (b) the Penal Taxi Stand shall be relocated to the Daisy Voisin Hub;
- (c) the Erin/Santa Flora Taxi Stand shall be relocated to the corner of San Fernando-Siparia-Erin Road and Railway Road; and
- (d) the Fyzabad Taxi Stand, shall be relocated to Siparia Old Road and Park Street.

7. Without prejudice to any other liability incurred by the Removal of commission of a traffic violation, a member of the Police Service may, in ^{vehicles} accordance with section 108 of the Act, remove or cause to be removed a vehicle that is parked in contravention of this Order, or left on any road in such a manner that it is likely to cause an obstruction to persons lawfully using the road.
