THE REPRESENTATION OF THE PEOPLE ACT, CHAP. 2:01

ORDER

MADE BY THE PRESIDENT UNDER SECTION 29(3) OF THE  
REPRESENTATION OF THE PEOPLE ACT

VARIATION OF PUBLICATION DATE (ANNUAL LIST OF  
ELECTORS) ORDER, 2025

WHEREAS section 29(1) of the Representation of the People Act (hereinafter referred to as “the Act”) provides, *inter alia*, that the Elections and Boundaries Commission shall, in respect of each electoral district, publish on 1st July of every year a list (hereinafter referred to as “the annual list”) of all persons qualified to be, and duly registered as, electors in that electoral district:

And whereas section 29(2) of the Act provides that the annual list shall continue in force until 30th June of the following year and on the commencement of an electoral registration shall be deemed to be the preliminary list of electors for that electoral district:

And whereas the annual list of electors published on 1st July, 2024 has been continuously updated and existing as at 18th March, 2025, on the records of the Elections and Boundaries Commission, and has been deemed by the Declaration of Existing List of Electors (Preliminary List of Electoral Registration) Order, 2025, published as Legal Notice No. 100 of 2025, to be the preliminary list of electors for the purposes of an electoral registration in the electoral districts in Trinidad and Tobago that commenced on 20th March, 2025, in relation to a general election of members of the House of Representatives which was held on 28th April, 2025:

And whereas by Proclamation published as Legal Notice No. 209 of 2025, it was directed that the 16th day of May, 2025, be fixed as the date of the termination of the electoral registration in each of the electoral districts of Trinidad and Tobago, thereby allowing the resumption of normal registration in Trinidad and Tobago with effect from 19th May, 2025:

And whereas the Elections and Boundaries Commission no longer recommends that the annual list of electors be published on 1st July, 2025 as is required by section 29(1) of the Act:

And whereas section 29(3) of the Act provides that the President may by Order in any year vary the date specified in subsections (1) and (2) wherever it appears that circumstances have arisen that warrant the variation:

Now, therefore, I, **CHRISTINE CARLA KANGALOO**, O.R.T.T., President of the Republic of Trinidad and Tobago and Commander-in-Chief of the Armed Forces, do hereby order that the publication date of the annual list of electors be varied from 1st July, 2025 to 1st September, 2025.
