REPUBLIC OF TRINIDAD AND TOBAGO

THE EMERGENCY POWERS REGULATIONS, 2025

ORDER

MADE BY THE MINISTER OF HOMELAND SECURITY IN ACCORDANCE  
WITH PARAGRAPH 2 OF THE SCHEDULE TO THE EMERGENCY POWERS  
REGULATIONS, 2025

DETENTION ORDER

WHEREAS it is enacted by Regulation 14 of the Emergency Powers Regulations, 2025, that the provisions of the Schedule shall have effect for the purpose of the preventive detention of persons:

And whereas it is provided in paragraph 2 of the Schedule of the Emergency Powers Regulations, 2025, that the Minister may, if satisfied with respect to any person that, with a view to preventing him from acting in any manner prejudicial to public safety and, it is necessary to provide for his preventive detention, make an order that he be detained and stating concisely the grounds for such detention:

And whereas it is further provided in paragraph 3(1) of the Schedule of the Emergency Powers Regulations, 2025, that any person in respect of whom a detention order is in force may be arrested without warrant by any police officer and may be detained in such place and under such conditions as the Minister may from time to time direct:

And whereas I, the Honourable Roger Alexander, Minister of Homeland Security, am satisfied with respect to KYLE FARRELL also called “RANDY ALI” also called “DARKO” also called “DRACO” of Lange Street, Gonzales, Port-of-Spain, and also of St. Andrew Street Blue Basin, Diego Martin, that it is necessary to provide for his preventive detention with a view to preventing him from acting in a manner prejudicial to public safety of Trinidad and Tobago:

Now, therefore, I, the Honourable Roger Alexander, Minister of Homeland Security, in exercise of the powers conferred on me, do hereby order that the said KYLE FARRELL also called “RANDY ALI”

also called “DARKO” also called “DRACO” of Lange Street, Gonzales Port-of-Spain, and also of St. Andrew Street, Blue Basin, Diego Martin, be detained, and do hereby authorise the Eastern Correctional and Rehabilitation Centre located at Santa Rosa, Arima or such other place as I may from time to time direct, as the place where the said KYLE FARRELL also called “RANDY ALI” also called “DARKO” also called “DRACO” of Lange Street, Gonzales, Port-of-Spain, and also of St. Andrew Street, Blue Basin, Diego Martin, shall be detained and so kept in lawful custody.

TAKE NOTICE that the grounds, upon which this detention order is made are as follows:

The detainee, KYLE FARRELL also called “RANDY ALI” also called “DARKO” also called “DRACO” (hereinafter referred to as “the detainee”), has been identified as a gang member within the meaning of the Anti-Gang Act and poses an immediate threat to public safety. This threat is established by information and intelligence, including sworn statements from person who can identify the detainee as a gang member.

The detainee, along with Terrence Maloney and Kareem King, has been identified as having access to a cache of high-powered rifles. All are suspects in an ongoing homicide investigation into the murder of Marvin Phillip.

The detainee is involved in a plan to assassinate Josiah Phillip in a planned reprisal killing for the murder of Terrence Maloney’s nephew on 13th July, 2025. Threats were also made by the detainee to member of the public on 18th July, 2025.
