MOTOR VEHICLES AND ROAD TRAFFIC ACT

THE TRAFFIC RESTRICTION (TEMPORARY PROVISIONS)  
(ST. JAMES, MARABELLA, SIPARIA AND SAN FERNANDO  
CHILDREN'S CARNIVAL PARADE OF BANDS) ORDER, 2025

1. This Order may be cited as the Traffic Restriction (Temporary Provisions) (St. James, Marabella, Siparia and San Fernando Children's Carnival Parade of Bands) Order, 2025.

2. This Order shall have effect in— Duration

- (a) St. James, from 12.00 noon to 7.00 p.m. on Sunday 23rd February, 2025;
- (b) Marabella, from 12.00 noon to 6.00 p.m. on Sunday 23rd February, 2025;
- (c) Siparia, from 1.00 p.m. to 9.00 p.m. on Friday 28th February, 2025; and
- (d) San Fernando, from 9.00 a.m. to 8.00 p.m. on Sunday 2nd March, 2025.

PART I

ST. JAMES

3. (1) Vehicular traffic and parking are prohibited on—

- (a) the Western Main Road, between Long Circular Road and George Cabral Street;
- (b) the westbound lane of the Western Main Road, between Nelson Mandela Park, St. Clair Avenue and Long Circular Road; and
- (c) the westbound lane of the Western Main Road, between Roxy Roundabout and Benares Street.

(2) Vehicular traffic shall not enter the Western Main Road, between Long Circular Road and George Cabral Street.

Two-way  
traffic

4. Vehicular traffic shall proceed in both directions along the eastbound lane of the Western Main Road, from Long Circular Road to Roxy Roundabout.

Band route

5. Bands shall proceed in a westerly direction, along the Western Main Road, between Long Circular Road and George Cabral Street to the judging point on the Western Main Road, in front of the St. James Park and Amphitheatre.

## PART II

### MARABELLA

Vehicular

prohibited

6. Vehicular traffic is prohibited on the Southern Main Road from Battoo Avenue to the Marabella Roundabout.

7. Vehicles proceeding—

- (a) north along the Southern Main Road, shall continue around the Roundabout onto Gopaul Lands, turn left onto Market Street, cross Union Road, proceed onto Battoo Avenue and turn right onto the Southern Main Road; and
- (b) south along the Southern Main Road, shall continue around the Roundabout onto Gopaul Lands, turn left onto Market Street, cross Union Road, proceed onto Battoo Avenue and turn right onto the Southern Main Road.

## PART III

### SIPARIA

Vehicular  
traffic  
prohibited

8. Vehicular traffic is prohibited from proceeding between High Street and Victoria Street along Coora Road on the following streets:

- (a) Daisy Voisin Street;
- (b) Edward Street; and
- (c) High Street, between Bermudez Street and La Pastora Street.

Parking and  
waiting  
prohibited

9. Parking and waiting are prohibited on—

- (a) Grell Street;
- (b) Gambal Street;
- (c) Oropouche Road, between High Street and Gambal Street;
- (d) La Pastora Street, between High Street and Victoria Street;

(e) Victoria Street, between Allies Street and La Pastora Street; and

(f) Mary Street, George Street and Allies Street, between High Street and Mary Street.

10. Vehicular traffic proceeding to Siparia from—

Vehicular  
traffic routes

(a) Erin towards San Fernando, shall turn south onto La Pastora Street, east onto Mary Street, onto Bermudez Trace and right onto the San Fernando-Siparia-Erin Road;

(b) San Fernando towards Erin, shall turn north onto Grell Street, onto Gambal Street and south onto Fyzabad-Siparia Old Road;

(c) San Fernando towards Fyzabad, shall turn north onto Grell Street, then onto Gambal Street and east onto Fyzabad-Siparia Road;

(d) Fyzabad, shall turn onto Gambal Street and then onto Grell Street; and

(e) Erin, shall turn onto Siparia/Fyzabad Road at the intersection of High Street and Siparia/Fyzabad Road Junction.

11. (1) The Erin taxi stand, shall be relocated to the entrance of the Siparia Market, opposite Ram and Sons Supermarket.

(2) The Penal and San-Fernando taxi stands shall be relocated to the western side of Bermudez Street, at the junction of San Fernando-Siparia-Erin Road.

PART IV

SAN FERNANDO

12. Vehicular traffic and parking are prohibited on—

(a) Royal Road;

(b) Coffee Street; and

(c) Ciperio Street.

13. Vehicular traffic proceeding west along Naparima-Mayaro Road, shall turn right onto Circular Street.

Right turn

14. Vehicular traffic proceeding west along Navet Road, shall turn left onto Bertrand Street.

Left turn only

Band route      15. Bands shall proceed from OWTU Building on Circular Road, right onto Royal Road, right onto Coffee Street, right onto Lord Street and then onto Mucurapo Street, between Keate Street and Harris Promenade.

Without prejudice to any other liability incurred by the commission of a traffic violation, vehicles found parked in contravention of this Order may be removed by the Police and impounded and dealt with in accordance with section 108(1)(b) of the Motor Vehicles and Road Traffic Act.
