THE EMERGENCY POWERS REGULATIONS, 2026

ORDER

MADE BY THE MINISTER OF HOMELAND SECURITY IN ACCORDANCE
WITH PARAGRAPH 2 OF THE SCHEDULE TO THE EMERGENCY POWERS
REGULATIONS, 2026

DETENTION ORDER

WHEREAS it is enacted by regulation 14 of the Emergency Powers Regulations, 2026, that the provisions of the Schedule shall have effect for the purpose of the preventive detention of persons:

And whereas it is provided in paragraph 2 of the Schedule of the Emergency Powers Regulations, 2026, that the Minister may, if satisfied with respect to any person that, with a view to preventing him from acting in any manner prejudicial to public safety and, that it is necessary to provide for his preventive detention, make an order that he be detained and stating concisely the grounds for such detention:

And whereas it is further provided in paragraph 3(1) of the Schedule of the Emergency Powers Regulations, 2026, that any person in respect of whom a detention order is in force may be arrested without warrant by any police officer and may be detained in such place and under such conditions as the Minister may from time to time direct:

And whereas I, the Honourable Roger Alexander, Minister of Homeland Security, am satisfied with respect to JAYLON GEORGE also known as “BOY BOY” of Upper Fairley Street, Bamboo Trace, Tunapuna, that it is necessary to provide for his preventive detention with a view to preventing him from acting in a manner prejudicial to public safety:

Now, therefore, I, the Honourable Roger Alexander, Minister of Homeland Security, in exercise of the powers conferred upon me, do hereby order that the said JAYLON GEORGE also known as “BOY BOY” of Upper Fairley Street, Bamboo Trace, Tunapuna, shall be detained at

the Youth Training and Rehabilitation Center, Golden Grove, Arouca, or such other place as I may from time to time direct, as the place where the said JAYLON GEORGE also known as “BOY BOY” of Upper Fairley Street, Bamboo Trace, Tunapuna, shall be detained and so kept in lawful custody.

TAKE NOTICE that the grounds upon which this detention order is made are as follows:

The detainee, JAYLON GEORGE also known as “BOY BOY” has been credibly identified by confidential intelligence as a member of the Rasta City/Seven Gang which is an Organised Crime Group (‘OCG’) within the legal definition of the Anti-Gang Act, 2021. He is a shooter for the OCG. The OCG has confirmed access to a cache of high-powered firearms and ammunition and has been engaging in territorial expansion resulting in public shootings, murders and trafficking of firearms, ammunition and narcotics. He and others plan to imminently carry out retaliatory shootings against rival gangs in public spaces using high-powered firearms and high-velocity rounds. His detention is necessary to disrupt these plans and to prevent further acts that pose a clear and present threat to public safety.

A Preventive Detention Order pursuant to regulation 14 of the Emergency Powers Regulations, 2026, is necessary to prevent him from acting in a manner prejudicial to public safety.
